BUYER'S RIGHT TO CANCEL

You may cancel this transaction, without penalty or obligation, within 3 BUSINESS DAYS from the date on the front of this agreement.

If you cancel, any property traded in, any payments made by you under the contract or sale, and any negotiable cancellation notice, and any security interest arising out of the transaction will be canceled.

If you cancel, you must send a tracking number of returned items to the seller or you must contact seller and make available to the seller at your residence, in substantially as good condition as when received, any goods delivered to you under this contract or sale; or you may if you wish, comply with the instructions of the seller regarding the return shipment of goods.

If you send goods back to the seller after the cancellation period, cancellation of contract will not be accepted as goods will be considered used and contract will be to remain in effect and buyer will remain obligated to purchase price. The seller has the right to return goods back to the buyer. If buyer refuses goods, seller will hold goods up to 20 days after seller receives back the refused goods without further obligation to buyer.

If you make the goods available to the seller and the seller does not pick them up within 20 days of the date of your notice of cancellation, you may retain or dispose of the goods without further obligation.
